7. That any additional amount required to carry on the business shall be provided or arranged by the partners here to in such manner and in such proportion as may be agreed from time to time. Interest at the rate of 12% per annum as simple interest or such lower rates as may be prescribed under section 40 (b) (iv) of the I.T. Act. 1961 or any other applicable provision may be in force for the income tax assessment for the partnership firm for the relevant accounting period shall be payable by the partnership from the amount Standing to the credit of the capital or current or loan account or any other account of partners. But the interest may be paid at lower/higher rate or may not be paid to the partners if so decided mutually. In case of loss, Interest will not be paid or in case of inadequate profit interest will be paid subject to availability of profit.

8. (i) All the above parties to this deed have agreed to actively devote their time and attention to the business of the partnership as working partners. It is here-by agreed that in consideration there of the working partners should be entitled to draw yearly remuneration in addition to the share in profit and interest on capital.

(ii) That the overall remuneration so payable to all working partners shall be divided among themselves as per profit sharing ratio. It shall be calculated as a percentage of the book profit for such accounting year in the following manner:



But in any case remuneration payable will not exceed the aggregate amount computed as per clause V of the section 40(b) of the I.T. Act. 1961, as amended by finance act 1992 read with explanations.

(iii) For the purpose of the above calculation the book profit shall be calculated on the basis of book profit as shown by the books and computed as provided in Sec. 28 to 44 D, chapter IV, of the I.T. Act. Without deduction the remuneration paid or payable to the partners for the relevant accounting year.

(iv) That the amount outstanding to the credit of the retiring partner as at the close of **31-03-2018** as Rs. 35,419=00 has been cleared by the firm through Cheque No. 069243 dt. 22-05-2018 drawn on Central Bank of India Branch Raigarh (C.G.) and acknowledged by the retiring partner. No amount is due to be paid to the retiring partner on any account. That the retiring partner shall not be entitled to use the firm name or similar names in future which would give an impression of his association with the firm.

(v) That the partners shall be entitled to withdraw any other amount during the year from the partnership towards their yearly remuneration, share of profit or out of their current loan or capital account or interest account from time to time as may be decided by the partners by mutual consent.


10. The Books of accounts shall be maintained and kept at the principle place of business. All the partners shall have full access to the same and they can obtain copies of account and extracts.

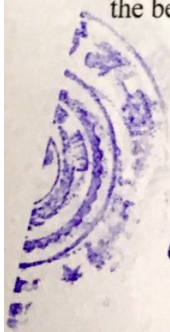

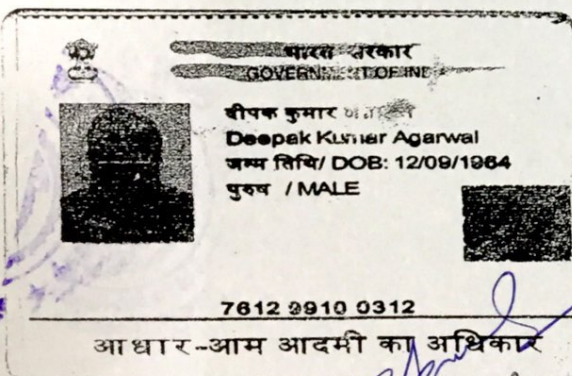

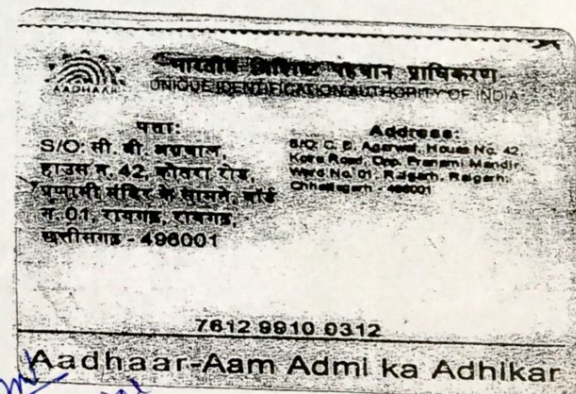
